Precautionary Statements

Prevention:

Keep away from heat, sparks, open flames, hot surfaces - no smoking. Do not spray on an open flame or other ignition source. Do not pierce or burn, even after use. Avoid breathing mist or spray. Response:

4. FIRST AID MEASURES

Inhalation: Move to fresh air. If not breathing, give artificial respiration. If breathing is

difficult, give oxygen. If symptoms develop and persist, get medical attention.

5. FIRE FIGHTING MEASURES

Extinguishing media: Water spray (fog), foam, dry chemical or carbon dioxide.

6. ACCIDENTAL RELEASE MEASURES

Clean-up methods: Ensure adequate ventilation. Remove all sources of ignition. Soak up with

sealed container for disposal.

or expose to temperatures above 48.9 °C (120 °F).
